Pageant Rules

- I understand that if I win any Title from Miss Freedom Fest Beauty Pageant in any age division **I agree to act in an appropriate manner when representing this title.**
- I understand and agree to **pay full payment 4 weeks before the pageant.** If not, you are disqualified with no expectation of a refund.
- I understand that the decision of the panel of judges is **FINAL!!!**
- I agree to abide by directives concerning judging procedures, pageant schedule, and to be a **team player.**
- I agree that **inappropriate behavior or bullying will not be tolerated by anyone.** Failure to comply will automatically disqualify you with no expectation of refund and you will be asked to leave.
- I understand that if I win any title from the Miss Freedom Fest Beauty Pageant in any age division, **I am responsible to attend at least half of events scheduled during reign.**
- I understand that if I win any title from the Miss Freedom Fest Beauty Pageant in any age division, **I will be responsible to be present when resigning my Title at the next pageant.**
- I understand that if I win the title, **I will notify director (Priscila Perales) before I present myself with my Title at any event not scheduled by the Miss Freedom Fest Beauty Pageant.** It is not prohibited, but a courtesy notice will allow us to respond to questions that may arise.
- I understand that **I must submit a photograph 1-3 weeks before pageant date.** This will be used for the Miss Social Media division.
- I agree that **I must sign the contestant entry containing the release of my photo, likeness, and image in connection with my participation in the pageant.**
- I understand that **I must abide by rules and regulations of age appropriate make-up and hair.**
- I agree that **I must turn in Tickets and Money by June 16 at dress rehearsal**
- I agree that I will **not post inappropriate content** (bad language, pictures or rants) on any Social Media Outlet. Failure to comply may result in disqualification or removal of Title.
- I agree that I will not hold the Miss Freedom Fest Beauty Pageant or any City of RGC employee, or the facility where the pageant is held responsible in the event of theft or injury as a result of any contestants participating in any events. Judging Criteria

- All Divisions **50 points**
 - ❖ Preliminary Criteria
 - Introduction **10 points**
 - Patriotic Outfit **20 points**
 - Formal Wear **20 points**
- Tie breaker: Application questions (0 – 5 points)**

Introduction includes the dance and the self presentation of each contestant.

The top three contestants in each category will be ranked according to total weight of combined points. Each judge submits a tally sheet for each contestant. These are collected by an impartial party immediately after the contestant concludes the individual presentation. Once all contestants have been presented, the points are tallied and final results are given to the MC.

NOTE:

Judge's annotation sheets will be sealed and become the sole property of the City of Rio Grande City.

All decisions of the judges are final and irrevocable.

No contestant or family member should converse or have contact with the judges.

Judges will have no personal relevance to any of the contestants.

FERPA: Parents may submit a written request for the annotation sheets only for their own child within 30 days of the contest.
