Acknowledgement, Waiver and Release from Liability. I acknowledge that the Color Rain Dash is a test of a person's physical and mental limits and it carries with it potential death, serious injury, property loss. I hereby assume the risks of participating in the color rain dash. I certify that I am physically fit, have sufficiently trained for the participation in this event, and have not been advised otherwise by qualified health professional. I hereby take the following action for myself, my executors, administrators, heirs, next of kin, successors and assigns, or anyone else who might claim or sue on behalf, and expressly acknowledge that it is my intent to take these actions. I agree to abide by the competitive rules adopted by the color rain dash (**b**) I agree that prior to participating in an event, I will inspect the racecourse, facilities, equipment, and areas to be used and if I believe any to be unsafe I will advise the person supervising the event, activity, facility, or area. (**c**) I waive, release, and discharge from any and all claims, losses, or liabilities for death, personal injury, partial or permanent disability, property damage, medical or hospital bills, theft or any damages of any kind, including economic losses (and loss) and/or stolen items, which arise out of or relate to my participation in, or my traveling to and from the event, the following persons or entities: the color rain dash, sponsors, run directors, employees, event hosts, volunteers, state and city, or localities in which the event is taking place, even if such claims, losses, or liabilities are caused by the negligent acts or omissions of the persons.
